- Location:** Central Alabama Gun Club in Shorter, Alabama

- Date & Time:** October 31, 2009
Registration - 8AM, Safety Briefing 8:30AM, 1st Relay starts at 9:15AM
Garand ,Springfield and Vintage Military Rifle Match – Relays 1& 2 (These matches will be fired simultaneously so you may fire in 2, but not all 3)
Carbine Match – Relay 3 (CAGC has 6 M1 Carbines – reserve a rifle and ammo for \$25, \$20 for jrs)
Rimfire Sporter Match – Relay 4
There will be a maximum of 20 shooters in each relay. A match may be cancelled if less than 5 shooters register. Register early to secure your spot.
- Ammunition:** Competitors may supply their own ammunition.
CMP .30-06 ammo will be available for purchase at club cost from CMP (\$10/40 rds).
CMP .30 Carbine ammo will be available for \$20/50 rds.
CMP .22lr ammo will be available for \$5/100 rds.
No tracer or armor piercing ammunition.
- Rules & Safety:** All CMP Rules apply, eye and hearing protection required, ECI's required.
ECI's will be available for \$1 each. Competitors will score targets/ pull range duties when not firing.
- Rifles:** Garand Match: As issue M1 Garands per CMP Rules
Carbine Match: As issue M1 Carbines per CMP rules
Springfield Match: As issue 1903 Springfield rifles as per CMP Rules
Vintage Military Rifles: As issue vintage military bolt or straight pull rifles as per CMP Rules
Rimefire Sporter: As per CMP rules (<http://www.odcmp.com/Competitions/rimfire.pdf>)
- Course of Fire:** 100 yard walk up range with SR-1 and Rimfire Sporter targets, 20 firing points.
- Garand Course "A" for Garand, Springfield and Vintage Match**
5 sighters maximum in 5 minutes
Slow prone: 10 shots for record in 10 minutes
Rapid prone from standing: 10 shots in 80 seconds
Standing: 10 shots in 10 minutes
- M1 Carbine Match Course for M1 Carbine Match**
10 sighters maximum in 10 Minutes
Slow prone: 10 shots in 5 minutes
Rapid prone from standing: 10 shots in 60 seconds
Rapid sitting from standing: 10 shots in 60 seconds
Slow standing: 10 shots in 10 minutes
- Rimfire Sporter Match Course for Rimfire Sporter Match**
Unlimited sighters in 10 minutes at 50 yards
Slow prone: 10 shots in 10 minutes at 50 yards
Rapid standing to prone: 2 series of 5 shots each in 25 seconds for semi-autos, 30 seconds for manual rifles
Slow sitting or kneeling: 10 shots in 10 minutes at 50 yards
Rapid standing to sitting or kneeling: same as rapid standing to prone
Slow standing: 10 shots in 10 minutes, 25 yards
Rapid standing: 2 series of 5 shots, 25 or 30 seconds, at 25 yards

Match Cost: Before October 31 - Adults, \$15 / Juniors (20 and under as of 12/31/09) \$5; 2 Matches \$20/\$10; All Matches \$25/\$15 (shoot as many as you want)

October 31 - Adults, \$20 / Juniors \$10; 2 Matches \$25/\$15; All Matches \$30/\$20

Awards: CMP Achievement Pins will be awarded for appropriate scores.

Miscellaneous: Bring food and plenty of water. Temperatures can vary widely in late October. Be prepared for any weather. The range has restroom facilities and running water. Campers welcome, but there are no shower facilities. There will be a hotdog cookout for lunch. Bring shooting mats, spotting scopes and or binoculars if you have them.
